Upon completion of application, the committee will select a deserving recipient scheduled to graduate North Yarmouth Academy in the spring of 2024. Scholarships are awarded based on school and community involvement and financial need.

The candidates who are chosen will demonstrate active community service, strong leadership skills, integrity, and appreciation for the benefits of being a part of the Yarmouth community.

These scholarships will be paid directly to the student in January of their college/trade school freshman year, dependent on each student achieving a 2.5 grade point average in their first semester. Recipients should submit a copy of their first semester grades to the Chamber as soon as they are available to receive funds.
